3 CHAIR' S STATEMENT / STATEMENT FROM THE BOARD

COVID-19

In these unprecedented times the COVID-19 pandemic has affected the way we work and learn. The staff at Eversley Primary School has undertaken enormous efforts to ensure, as far as possible, that your children are supported through this difficult time in their lives. The Governing Body would like to thank everyone for their support during these challenging events; pupils for learning in a new way, parents for supporting them and staff for all their hard work.

It is a credit to the headteacher and her staff that Eversley reopened in June 2020 to Reception, Year One and Year Six pupils as well as remaining open throughout this pandemic to children of critical workers and vulnerable children in all year groups.

Throughout this period the Governing Body continued with virtual committee meetings and working with the school to support their hard work. We have been so impressed with everybody's commitment in adapting to this new environment.

We continue to support the work of the school in our strategic role such as:

- oversee the provision of home schooling for many pupils and in-school provision for children of key workers
- ensure pupils still enjoy school, feel valued and part of the school community
- ensure clarity of vision, ethos and strategic direction
- ensure pupil attainment is monitored and maximised
- oversee and approve the school' s budget
- ensure the staff are supported as needed
- approve policies and procedures
- oversee admissions of Reception pupils

Much of our work centres on the governors' own development plan and that of the school. In line with this, we regularly review our roles and the experience, knowledge and skills we individually bring to the Board, ensuring there are no gaps that could affect our efficient governance of the school. We continue to identify suitable training through an online training portal.

We have access to an independent training and clerking service who are available for advice if needed, and who provide training and meetings to help us to remain well informed.

We continue to review policies and procedures to ensure that these are fit for purpose and meet not only our legal responsibilities but also our vision and aims for the school and our pupils. The children and staff remain at the forefront of our decisions as we endeavour to provide the best educational environment for them.

Eversley Parliament

We were delighted to welcome the introduction of the Eversley Parliament which enables pupils to have a voice and be involved in key decision making, supported by the leadership team.

The Eversley Parliament provides pupils with meaningful opportunities to understand how to be responsible, respectful, active citizens who contribute positively to society. Pupils do this by representing the voices of their peers and taking part in formal meetings throughout the school year. The parliament is actively involved in encouraging the rights of all pupils to be involved in decisions that affect them and their education. The different cabinets are: Teaching and Learning, Enterprise, Enrichment, Mental Health and Wellbeing, Values and House Captains, Finance and Environment. The achievements of the committees are promoted in the school newsletters.

Class Transition Picnics

We were thrilled that the school managed to organise transition picnics for all the school years. This gave the children the opportunity to catch up with some of their friends, see their current teacher and for pupils up to Year 5 meet their new teacher in September 2020. We know that this was a special moment for many of the children.

Year 6 Leavers Week

Year 6 pupils have had an opportunity to celebrate their time at Eversley with some wonderful activities so they can leave the school with great memories and have had the opportunity to say goodbye to their friends. We want to thank the school for organising this special week for these pupils.

September 2020

The school are working incredibly hard in formulating a programme for September 2020. The planning process is ongoing, but measures aligned with government guidance will be in place to welcome back all Eversley pupils this September. There will be a rebuild process and the school will plan for pupils and staff to have the opportunities to recognise that something big has happened; rather than 'moving on' we will firstly need to make time to reflect on what has happened and the impact this has had at all levels. It is hoped that a formal School Development Plan can be formulated to commence Spring 2021, subject to the progress of the pandemic.

Local Authority Governor

It is with a heavy heart to announce that Ingrid Cranfield has resigned from the Governing Body. Ingrid has been a governor at Eversley for over 20 years and across various schools for 32 years. Ingrid was Chair of the Governors at Eversley for 12 years and was the current Vice-Chair. During her governorship Ingrid's support has been invaluable to many of us that have passed through the doors of Eversley. Ingrid's tremendous experience and skills will be sorely missed, and we would like to thank her for volunteering her numerous years of support and mentoring.

Paul was a co-opted governor and we are very thankful for all his commitment and energy. Paul has been both a parent and governor at Eversley and we are extremely grateful for his support over many years.
